5. Tax Clearance Certificate (for the period of available audited accounts, as above) or equivalent (for Norwegian entities)

For our Individual member applicants and/or Corporate applicants with less than 3 years of audited accounts, we require one “Reference Statement of Good Standing” for each year that Corporate audited accounts are not available, duly endorsed by qualified Legal, Accounting or Financial Officers. Since we require 3 years of audited accounts, we request that our Individual Members provide us with 3 Reference Statements of Good Standing. We also request that no two statements are annotated by the same qualified Officer. A template copy of our Reference Statement of Good Standing is attached below for your use.

Please forward all required documents to us by email at info@nigeria-norway.org.ng or by post to our address detailed below. We will process your application to the Chamber promptly just as soon as we receive the required documents and, subject to approval by the Chamber Board, we hope to congratulate you by invitation to accept our offer of membership of the Chamber at the earliest opportunity.
