Value of Norwegian exports To the UK 2018

6.2 billion NOK (+18%) 575 million GBP (+16%)



Salmon 4.3 billion NOK (+21%) 395 million GBP (+19%) 68,5 thousand tons (+21%) Cod 526 million NOK (-4%) 48 million GBP (-6%) 12 thousand tons (-18%)



Agreements regulating the trade

WTO GATT

- The EEA Agreement
 - Protocol 4 to the EEA Agreement (PEM)
 - Protocol 9 to the EEA Agreement (fish)
 - Annex I to the EEA Agreement (veterinary)
- EC-Norway trade agreement (1973)
- Compensation Agreements 1995, 2004, 2007





3 possible scenarios

Best case

- But not very likely right now...
- No change for all practical purposes we keep calm an carry on for another 21 months.
- > Or remain until further notice.

Worst case

- WTO regulated trade
 China, US, Brazil for example
- > No preferential trade
- MFN rates on import to the UK
- Veterinary 3rd country trade



Veterinary requirements

- From internal market to 3rd country trade
 - Border control
 List of establishments
 Health certificate
- i.e serious administrative burdens

Quotas and tariff measures?



Aim at not interrupting trade – 30 March 2019, "ideally (and unless the UK decides to stay).

Other risks to this scenario?

Rules of Origin

- Bigger risk than uncertain tariff treatment
- Regulates all preferential trade between Norway and the EU
- For a party to acceede to the PEM convention it needs at least one free trade agreement with one of the other parties to the convention.
- Does the UK fulfil this requirement?

 - Customs duty 2%
 - Quota at 0 duty: 6100 tons (exhausted on 5 January)
- Frozen
 - > Duty 2%
 - > Quota at 0 duty: 580 tons
- > Filets
 - Duty 2%
 - Quota at 0 duty 610 tons (exhausted on 3 January)
- Smoked
 - Duty 13%
 - > Quota at 0 duty: 450 tons

- Fresh
 - Customs duty 2%
- Frozen
 - Customs duty 2%

Cod

Today

- Fresh and frozen
 - O duty for Norwegian origin
 - Duty free quota of 7500 tons not requiring origin (erga omnes)
- Filets
 - > 0 duty for Norwegian origin
- Frozen filets
 - > 0,9% duty for Norwegian origin
 - Duty free quota of 9000 tons for Norwegian origin
 - Duty free quota of 50000 tons not requiring origin

- > Fresh
 - Customs duty 12%
- Frozen
 - Customs duty 12%
- > Filets
 - Customs duty 18%
- Frozen filets
 - Customs duty 7,5%

Haddock

Today

- Fresh and frozen
 - > 0 duty for Norwegian origin
- > Filets
 - > 0 duty for Norwegian origin
 - Duty free quota of 180 tons
- Frozen filets
 - > 0,9 % customs duty for Norwegian origin
 - Duty free quota of 9000 tons for Norwegian origin

- Fresh and frozen
 - > 7,5% customs duty
- > Filets
 - 18% customs duty
- Frozen filets
 - > 7,5% customs duty

Shrimps and Prawns

Today

- cold water shrimp raw or boiled
 - > 12% customs duty
 - Combined duty free quotas of 2750 tons with Norwegian origin
 - Duty free quota of 4000 tons without Norwegian origin
- Prepared or preserved
 - 7,5% customs duty
 - Combined duty free quotas of 20500 tons for Norwegian origin
 - Duty free quota of 7500 tons without Norwegian origin

- cold water shrimp raw or boiled
 - > 12% customs duty
- Prepared or preserved
 - 20% customs duty
